REPORT AND RECOMMENDATION OF THE REVIEW PANEL

CANTERBURY EARTHQUAKE (RESOURCE MANAGEMENT – ELECTRICITY NETWORK RECOVERY) ORDER 2011 AND CANTERBURY EARTHQUAKE (RESERVES ACT-ELECTRICITY NETWORK RECOVERY) ORDER 2011

- 1. On 19 August 2011 the Canterbury Earthquake Recovery Review Panel (the Review Panel) considered the Canterbury Earthquake (Resource Management Act Electricity Network Recovery) Order 2011 (version PCO 15265/5.0) and the Canterbury Earthquake (Reserves Act-Electricity Network Recovery) Order 2011 (version PCO 15346/5.0).
- 2. The Review Panel considered the joint letter from Kevin Currie of the Ministry for the Environment and Doris Johnston of the Department of Conservation dated 15 August 2011. The Review Panel sought further information on the 18 August 2011 seeking clarification on the temporary or permanent status of structures and the impact on the usability of Porritt Park. The Ministry for the Environment provided further information about the draft Order in a letter dated 18 August 2011.
- 3. The Review Panel noted that the objective of the proposal is to facilitate recovery by expediting Resource Management Act 1991 and Reserves Act processes for electricity network recovery works in Christchurch.
- 4. The further information about the proposal provided to the Review Panel contained advice from Ministry officials that:
 - a. The Orders provide that any licence or resource consent granted for the temporary 66Kv lines will expire on the expiry of the Canterbury Recovery Act 2011, if not before. Any permanent replacements to the 66kV lines will not be covered by the provisions of these Orders and will require any necessary authorisations to be granted by the relevant local authority;

- b. the new substation on Rawhiti Domain is to be a permanent fixture; and
- c. the route of the 66kV temporary line across Porritt Park has no immediate impact on the use of the park.
- 5. The Review Panel noted that there is uncertainty about the future customer base and demand for electricity within the Eastern suburbs in the longer term, and the difficulty Orion faces in planning a more permanent solution. The Review Panel considers the Orders are an appropriate use of the Canterbury Earthquake Recovery Act 2011 powers and a pragmatic approach to the challenges of maintaining a viable and reliable power supply into the Eastern suburbs while the City works its way through the recovery and reconstruction phase. The Review Panel noted that the Orders expire in April 2016 and that the Orion will need to apply for their on-going presence and operation under the then-existing regulatory regime.
- 6. The Review Panel is of the view that the draft Orders are necessary, expedient and meet the purposes of the Canterbury Earthquake Recovery Act 2011.

Recommendation

 The Review Panel recommends to the Minister for the Environment and the Minister of Conservation that the Canterbury Earthquake (Resource Management Act – Electricity Network Recovery) Order 2011 (version PCO 15265/5.0) and the Canterbury Earthquake (Reserves Act-Electricity Network Recovery) Order 2011 (version PCO 15346/5.0) be made without change.
